ADMINISTRATIVE ORDER NO. 95-20

RE: ASSIGNMENT OF JUDGE FOR MULTI-CASE MANAGEMENT

The motion for assignment of judge for multi-case management is granted.

The referenced causes of action attached thereto together with any other causes as may hereafter be so ordered by the judge hereinafter named are assigned to the Honorable Thomas H, Needham for the purpose of managing, supervising, scheduling and disposing of such pre-trial discovery motions, dispositive motions, discovery proceedings, and all other pre-trial matters pertaining to such causes.

All motions that have been filed and are presently scheduled to be heard after the date of this order are reassigned to Mr. Justice Needham who will schedule the date on which such motion is to be heard.

Mr. Justice Needham is empowered to issue special orders for the due administration of these causes of actions.

Nothing in this Administrative Order 95-20 shall prevent its modification by Mr. Justice Needham where the circumstances of a given case or the interests of justice require.
