ASBESTOS-RELATED LITIGATION

The Motion for Assignment of Ms. Justice Gibney for Multi-Case Management is granted.

Nothing in this Administrative Order 96-2 shall prevent its modification by Ms. Justice Gibney or Presiding Justice Rodgers where the circumstances of a given case or the interests of justice require.
