

ADMINISTRATIVE ORDER 2020-07

The Superior Court will work to safeguard court users and court personnel as we continue to operate calendars and handle court matters in our courthouses and via remote WebEx technology. Hearings and conferences that are conducted remotely are encouraged and will continue to be supported by personnel who are specifically trained for this purpose. Public access to court proceedings will continue to be available through YouTube streaming and all scheduled hearings and associated YouTube channels shall be posted on the Judiciary website.

The following provisions shall remain in effect through September 7, 2020 unless or until superseded by subsequent administrative order.

IN-PERSON HEARINGS

Non-emergency matters that cannot be handled remotely shall be conducted in-person on a limited basis. Calendars will continue to be staggered to ensure compliance with the courthouse and courtroom capacity limits and the social distancing guidelines set forth in Supreme Court Order No. 2020-12. Judicial Officers shall ensure that courtroom capacity levels are adhered to and that social distancing and face mask protocols are respected.

The following calendars will continue to operate through September 7, 2020 in Providence County: Daily Criminal Calendar, Miscellaneous Criminal Calendar, Trial/Pre-Trial Calendar, Pre-Arrestment Conference (PAC) Calendar, Civil Calendar. In Kent County, the following calendars will operate through September 7, 2020: Daily Criminal Calendar, Civil Calendar, and Newport/Washington County Criminal/Civil Calendar.

Video conferencing with defendants at the Adult Correctional Institution will continue to be utilized wherever practicable on the Providence and Kent County Daily Criminal Calendars and the Providence County PAC Calendar. For in-person hearings, calendar events will be staggered throughout the day to meet social distancing requirements.

Adult Drug Court and Diversion calendars will resume on a limited basis the week of June 15, 2020.

For proper distancing purposes and gathering restrictions, specific courtrooms in Providence County and Kent County will continue to be used for the duration of this Order and are noted on the attached Duty Justice and Magistrate assignment list.

GRAND JURY

Grand Jury proceedings have been underway since May 18, 2020 and will continue to operate in a location (s) that provides for suitable social distancing and appropriate safety measures.

CRIMINAL AND CIVIL JURY TRIALS

All Criminal and Civil Jury Trials scheduled to commence between March 16, 2020 and July 31, 2020 shall be continued to a date no earlier than September 8, 2020 and will only take place provided social distancing and precautionary measures are implemented to ensure the safety of jurors, attorneys, witnesses and court personnel.

BENCH TRIALS – CRIMINAL AND CIVIL

All criminal and civil bench trials are continued to a date no earlier than July 1, 2020 unless explicitly authorized by the Presiding Justice.

COVID -19 RELATED CALENDAR PROTOCOLS/ORDERS

All calendar protocols/orders issued in response to the Covid-19 pandemic as well as any modifications or amendments, thereto shall remain in full force and effect unless superseded by a subsequent protocol/order.

ACCESS TO CLERKS' OFFICES

Clerks' offices shall continue to conduct court business in all emergency and non-emergency matters, including but not limited to accepting the filing of pleadings and other documents, scheduling hearings, and issuing orders. Through the duration of this order, pro se litigants may continue to submit filings via email to the clerk's office. Email information for each county is available on the Judiciary website.

Except for emergency matters all in-person filings or business with Clerks' Offices must be made by appointment only. Instructions on scheduling an appointment and telephone contact information for each county Clerk's Office is available on the Judiciary website.

RESTITUTIONS AND/OR COURT COSTS & FINES – PAYMENTS

Individuals are encouraged to make restitution and/or court costs & fines payments on-line via the Rhode Island Judiciary Public Portal or by U.S. Mail. Otherwise, a scheduled appointment will be required for those who wish to make an in-person payment. Instructions for making payments and contact information for the Office of Central Registry and the Costs & Fines Office may be found on the Rhode Island Judiciary website.
