Pursuant to title 8, chapter 8.3 of the General Laws of Rhode Island, the Petitioner requests that the court enter an extreme risk protection order.

1. Upon information and belief, the Respondent poses a significant danger of causing imminent personal injury to self or others by having in the Respondent's custody or control, or by purchasing, possessing, or receiving a firearm based upon the following grounds:

3. Pursuant to title 12, chapter 5 of the General Laws of Rhode Island, the Petitioner has concurrently filed a sworn affidavit for a search warrant for the search of any firearms in the possession, custody, or control of the Respondent.

4. I certify that to the best of my knowledge the Respondent is not in the military service as defined by the Servicemembers Civil Relief Act (50 U.S.C. §§ 3901, et seq.) and is not a member of the national guard on state active duty for a continuous period exceeding ninety (90) days as defined by G.L. 1956 § 30-7-10.

5. The following are all known restraining orders, orders of protection and pending lawsuits, complaints, petitions, or actions pending, active or filed within one (1) year prior to the petition involving the Respondent, but not limited to, an order entered pursuant to title 8, chapter 8.1 or title 15, chapter 15 of the Rhode Island General Laws:

6. The following is the number(s), type(s), and location(s) of all firearms in the Respondent's current ownership, possession, custody, or control:

The Petitioner requests that the court enjoin the Respondent from having in the Respondent's possession, custody, or control any firearms and further enjoin the Respondent from purchasing, receiving, or attempting to purchase or receive any firearms while an order is in effect.

I request that the above relief be ordered because it clearly appears from specific facts shown by affidavit and by this Petition that the Respondent poses a significant danger of causing imminent personal injury to self or others by having in the Respondent's custody or control, or by purchasing, possessing, or receiving a firearm before notice can be served and a hearing had thereon. I understand that the courts will schedule a hearing no later than fourteen (14) days after such order is entered on the question of continuing such temporary order.
