#### NOTICE:

It shall be the responsibility of the Contractor to notify all subcontractor and suppliers he proposes to use for the various parts of the work of any changes or modifications contained in this Addendum. No claim for additional compensation due to lack of knowledge of the contents of this Addendum will be considered.

#### Pre-Bid Meeting:

A Mandatory Pre Bid Conference was held on September 3, 2019 at 7:30 AM in the front lobby. The following items were discussed:

- Bids are due Tuesday September 17, 2019 at the Purchasing Office, Room 1006, at the RI Traffic Tribunal located at the Pastore Center, 670 New London Ave. Cranston, RI. Bids must be delivered before 10:00 AM to be considered.
- 2. Bids must be submitted with a 5% Bid Bond for the full cost of the Bid.
- 3. This project is a prevailing wage project with certified weekly payroll.
- 4. This project is RI Tax exempt.
- 5. All employees working within the building regarding this project must submit to a background check and obtain approval from the Courts prior to the start of the project.
- 6. Hours of work shall be 5:00 PM to 12:00 AM, Monday through Friday. Work on Saturdays will be allowed at no additional cost to the project. All overtime work must be coordinated with Steve Kerr's Office.
- 7. All present at the pre-bid meeting toured the lobby, corridors, a typical courtroom, and the basement.

#### **Clarifications:**

The following questions were submitted:

 If we follow the sequence of operations as noted above but changing over one or two zones a night, will this mean that we need to have the new radio box installed and operational so if the new zone (tied into the addressable system) goes into alarm the fire department will be notified? Keep in mind that we would need to keep the old master box online to handle the old system.

If the new addressable system goes into alarm, what will set off the existing horn strobes?

The Electrical Contractor shall interconnect the existing conventional fire alarm control panel and the new addressable fire alarm control panel. If an initiating device goes into an alarm on the existing conventional fire alarm control panel or the new addressable fire alarm control panel, then the notification devices shall operate.

2. Is it the contractors' responsibility to design the new NAC loops needed for the new notification devices including booster panels, associated devices and connection to the SLC loops? We ask because there wasn't a one line provided with any of those details.

The existing fire alarm system has two (2) existing to be reused notification device circuits. The specified LED horn/strobe units and the specified LED strobe units shall operate on the existing to be reused two (2) notification device circuits.

3. Can the work hours be extended beyond 12AM?

Work hours cannot be extended beyond 12 AM unless arrangements are made with the owner.

4. Would it be possible to work a full weekend from Friday night to Sunday night?

No work shall be allowed on Sundays. Work on Saturdays will be allowed at no additional cost to the project. All overtime work must be coordinated with Steve Kerr's office.

5. Who will carry the costs for the sprinkler testing company to come out and run flow tests to verify operation of the flows and temper switches? If we are to provide, please provide contact information for the testing company and account manager.

The Electrical Contractor shall include the cost of the sprinkler testing company in the Electrical Bid. This is the contact information for the owner's sprinkler testing company:
