RHODE ISLAND FAMILY COURT  
CHILD SUPPORT FORMULA AND GUIDELINES

In accordance with federal requirements, in the fall of 2011 the Rhode Island Family Court convened the Child Support Guidelines Committee to review the 2007 Child Support Guidelines. The Committee completed its work in February 2012, submitting its final report along with a proposed 2012 Monthly Basic Child Support Obligations Schedule, and a proposed 2012 Gross to Net Conversion Table. The Committee also suggested an approach to resolving issues related to change in work related child care expenses.

The Rhode Island Child Support Guideline Schedule of Basic Child Support Obligations, promulgated in Administrative Order 2007-03 has been amended. The 2012 amended Monthly Basic Child Support Obligations Schedule is attached hereto and is effective June 4, 2012.

The new schedule shall apply to all child support orders established or modified by the Family Court on or after June 4, 2012, including temporary orders, final orders, or orders entered into by agreement of the parties.

The revised schedule incorporates economic changes which have occurred since 2007 in federal tax rates, federal poverty guidelines, inflation, price levels and housing costs in Rhode Island. The federal self-support reserve has been increased from \$851 net per month (\$939 gross) to \$907.50 net per month (\$1,020 gross), to correspond with increases in the poverty level since the last revision in 2007. The inclusion of a self reserve insures that obligors have sufficient income to maintain a minimum standard of living. However, absent a deviation, the recommended minimum support order set forth in the schedule is Fifty Dollars (\$50) per month to establish an obligor's duty to support his or her children.

The amended schedule is based on the Income Shares Model previously adopted by the Family Court. The amended schedule continues to calculate child support as a shared obligation wherein each parent's income is considered as if the child continues to reside in an intact household. See Family Court Administrative Order 87-2.

Adopting the recommendation of the Committee, in those cases where work-related child care costs have been calculated into the child support order and those costs are subsequently modified or terminated, this Administrative Order requires reasonable immediate notice of that change to the obligor by the obligee. Accordingly, Administrative Order 87-2, is amended to add Sec. IV-B(7)(b).


Therefore:

**(b) In all orders of child support which include child care costs, the Court shall, unless otherwise inappropriate, order that the obligee/parent shall provide reasonable immediate notice to the obligor of a reduction or termination of child care costs and the date that said reduction or termination occurs.**

**If the Court determines that the obligee/parent failed to provide reasonable notice to the obligor of a reduction or termination of child care costs, the Court may exercise its discretion to impose an appropriate remedy/consequence.**

The OCSS1, which is attached hereto, may be substituted for the DR-6 only in child support actions brought by the Office of Child Support Services, (OCSS) (after June 1, 2012).

In all other respects, not inconsistent herewith, the procedures set forth in Administrative Orders 87-2, 97-8, 2002-3 and 2007-3 should be followed.
