#### **Eligibility Requirements**

- § Charged with an alcohol or other drug (AOD) offense or charged with another nonviolent offense but with a history of AOD use or abuse.
- § Exhibits a history of AOD use, dependency, or abuse.
- § No pending charge involving a felony crime of violence.
- § No pending charge involving the delivery of a controlled substance or possession with intent to deliver a controlled substance.
- § Indicate willingness to enter a plea of nolo contendere (no contest).

#### **Frequently Asked Questions**

### How can I apply to the Adult Drug Court Program?

Any time after the arraignment of an eligible individual by submitting a referral form to drugcourt@courts.ri.gov.

Once the referral form is received and staff confirms the individual is legally eligible to participate in the program, staff will reach out to your attorney and a court date will be assigned.

# What happens if I violate the terms of the program?

You will be given an opportunity to be heard by the court concerning the nature of the violation as well as any mitigating information. The court will then make a decision concerning your continued participation in the program and whether any additional conditions need to be imposed. For extreme and repeated violations, you may be terminated from the program resulting in the imposition of the previously agreed upon sentence.

## What are the benefits of participating in the program?

- § Resolve your case with dismissed charges.
- § Obtain sobriety.
- § Connect to services.
- § Engage in treatment as an alternative to jail.
