To help you on your way to full health, The Trust Preferred Physician Network, or PPN, has been developed as part of our workers' compensation program. The Trust PPN consists of Rhode Island health care professionals that span eleven medical specialties and have been carefully selected to ensure you receive the best possible treatment.

USING THE TRUST PPN IS EASY AS 1-2-3

When you are injured on the job, you have the right to select a doctor of your choice for your initial visit and ongoing treatment. To save you time and effort, The Trust has carefully researched and compiled a network of the best doctors available and encourages you to make your selection from this booklet. If you decide to change doctors after your initial visit, you must choose one from The Trust PPN. (If your initial visit was made to an emergency room, it would not count as your first choice of a provider outside the network.)

Tell your doctor at the time of your visit that you were injured at work. Your doctor will then send all bills directly to The Trust for hassle-free processing.

You will receive a prescription card that allows you to participate in The Trust's prescription drug program. The card will be sent to you from "myMatrixx." Through this program, you will be able to conveniently purchase outpatient prescription drugs without having to fill out claims forms or pay any out-of-pocket expenses. For your long-term needs, you will also have access to a home delivery service. You will receive more information, including the names of participating pharmacies with your prescription card.
